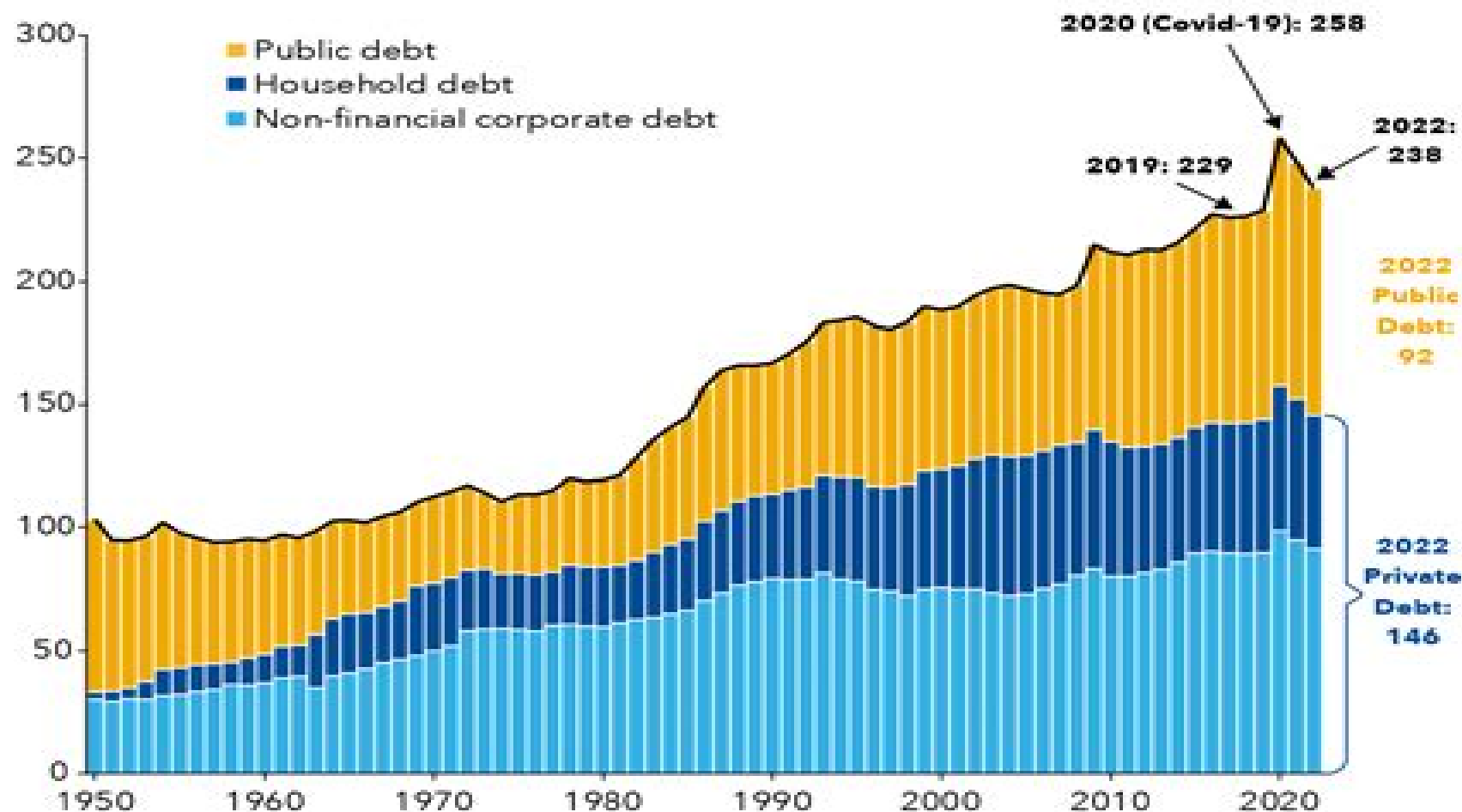


## Pandemic blip
