Congo Colombia and Sri Lanka Since the end of the Cold War it has been common for weak state rulers with formal state legitimacy but not empirical legitimacy to have continued to enjoy international recognition because of international fears that they are the only barrier against a total collapse Amongst other things this paved the way for an expansion of the market for private military and security companies PMSC such as the South African based Executive Outcomes EO in the 1990s However the lack of state capacity led to a sub contracting willingly or unwillingly of the state s monopoly on the use of force to non state actors PMSCs and semi state actors like local militias warlords criminal gangs and vigilant groups in an attempt to secure weak state leaders positions In the competition for state control internationally recognised leaders have an advantage over their non state rivals because they can seek military help outside their countries with the agreement of the international community and in accordance with international law
