#### (1) FACT PATTERN: "PASTELS AND PRINTS"

Samantha and Tim plan to divide up the sale price of the gallery (a downtown commercial property) and whatever money they receive on the sale of the remaining merchandise that they currently have in stock. Samantha hopes that the sale proceeds and inventory profits should be in the range of (total) \$500,000. Samantha has known Tim for years. Until now, the business relationship between them has been great. However, after they decided to sell Pastels and Prints, things have been difficult. Last Friday, during negotiations between Samantha and Tim regarding how to divide up the proceeds of the sale of the business, things broke down totally. Tim stormed out of the meeting room at the gallery and Samantha has not spoken with him since. Even though communications are tough at the moment, she tells Dominic that she still cares for and trusts Tim. She would rather not lose him as a friend. Samantha also tells Dominic that - other than the money that is tied up in their business - Tim does not have a lot of financial resources. Further, Tim and his spouse are leaving the country soon (to take up work in a small community in Mexico that is famous for its paintings and galleries). She is certain, therefore, that he will return shortly looking to finalize the sale, which he would like to make happen as soon as possible before he needs to leave the country. Samantha asks Dominic if he would act as her lawyer in her negotiations with Tim regarding the sale of Pastels and Prints. Dominic agrees.
