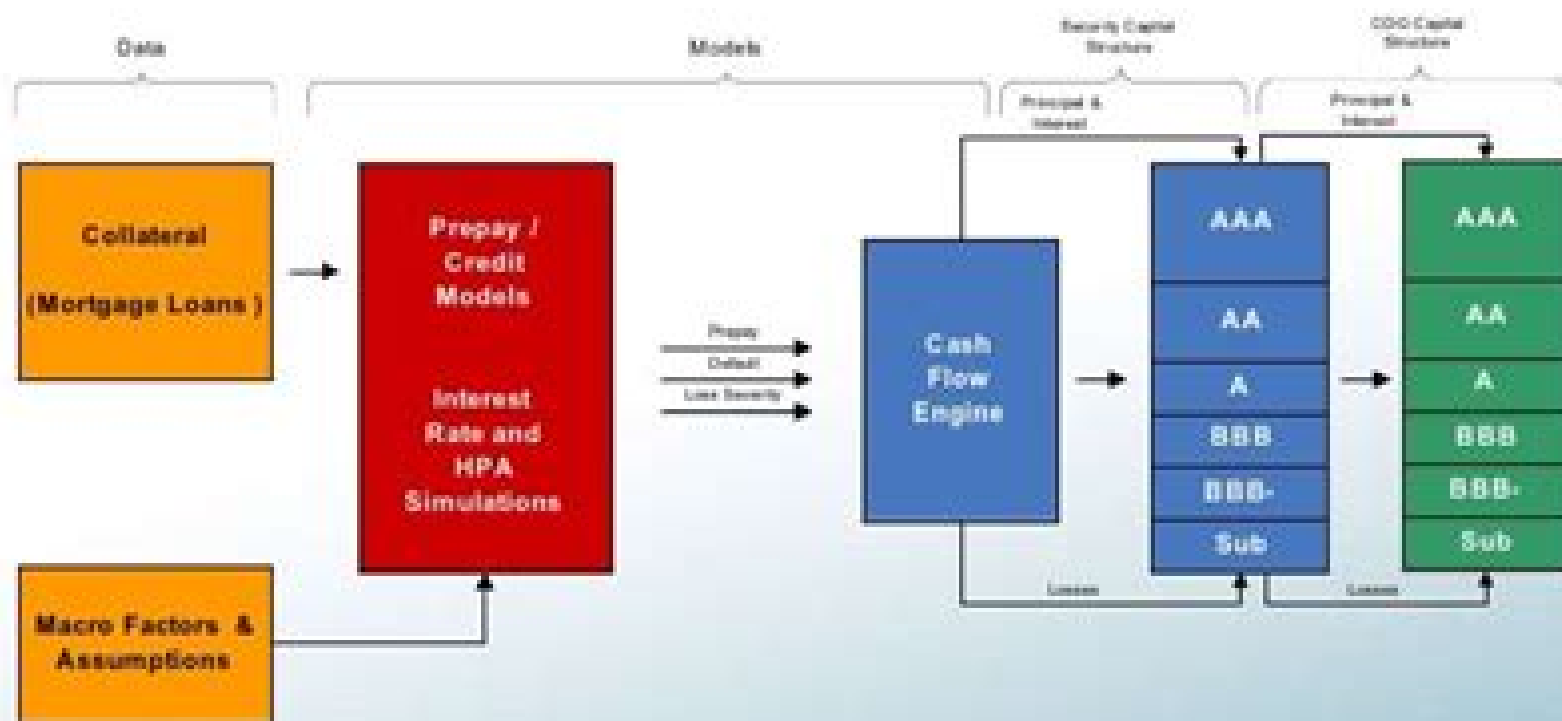


MBS Valuation Flowchart
